

Instructions for completing the Licensing Form

Authors and their faculty advisors must sign this form after submitting a manuscript for publication to the Undergraduate Science Journal. Authors of approved articles will be notified via email in March 2023 to sign the USJ Licensing Form.

The Licensing Form will be sent to authors and faculty advisors by email through DocuSign, which allows individuals to sign documents electronically. Users do not need to create an account to sign a document through DocuSign, but users will need to use a UCLA-registered email.

The Licensing Form will be completed in two steps:

1. **The undergraduate author signs the Licensing Form.** Undergraduate authors will be the first user prompted for a signature. Authors will be prompted to enter the title of their manuscript, full name, email address, and signature. All fields are clearly marked. The document is officially signed and submitted after clicking "FINISH."
2. **The faculty advisor signs the Licensing Form after the undergraduate author has signed.** After the undergraduate author has signed the form, the faculty advisor will receive an email from DocuSign prompting them for their signature next. Advisors will be prompted to enter their full name, department, email address, and signature. All fields are clearly marked. The document is officially signed and submitted after clicking "FINISH."
